

## **Updates from our Grant Recipients**

Last June, the Billings Community Foundation was pleased to award grants to 14 different nonprofits in the region. The total amount for all grants awarded in 2013 was \$15,000. The programs awarded were meeting needs in areas ranging from animal welfare, children's programming, senior services, domestic violence, employment training, Yellowstone River clean-up and the Zoo. Many of these recipients are now sending follow-up reports to the foundation. The work these groups do on a limited budget is truly amazing. Here are some excerpts:

The Bridger Community Food Bank, with the help of their grant, is able to provide fresh ground beef to their clients every day Endowment Accounts for Billings Studio Theater, Arts Without Boundaries and Big Sky Senior Services/Prevention of Elder Abuse. With the "Bison for Bruce" program, we have initiated Fiscal Sponsor relationships and we are pleased to announce that BCF now offers locally invested Donor Advised Funds.

During 2013, we established the "BCF Endowment Fund" and have an anonymous \$5,000 matching gift that will double the first \$5,000 received. Your gift designated for the "BCF Endowment Fund" would help us meet this challenge. Also, BCF has developed new programs to recognize our supporters and created new sponsorship opportunities. These programs are outlined in the following article. We have recently added a PayPal button to our BCF website, allowing us to receive donations online. Please consider participating in one of these opportunities to help us improve our service to individuals and nonprofits in the Billings area. We would like to include you in our "List of Supporters".

In addition, the Board has adopted a "Three Year Plan" for development that we believe will take our service to the Billings area to "the next level". If BCF can secure \$15,000 to \$30,000 in donations, grants, in-kind gifts and/or pledges for each of the next three years, we can hire a full time Executive and establish a permanent office. We believe this will allow BCF to increase the grants made to area nonprofits and enhance our Client Services. We believe future income from sponsorships, donations, service fees and endowment will sustain operations in future years.

that the food bank is open (two days per month) rather than one day per month.

Kayhan Ostovar, associate professor of environmental studies at Rocky Mountain College, reports that with our grant and other generous donors, his <u>Yellowstone River Research Group</u> saw the biggest turnout ever. In September, 35 people hopped into canoes, metal boats, rafts and kayaks on a Saturday morning to scour the river and riverbanks for trash - all part of the seventh annual Yellowstone River Cleanup.

Big Horn County Library in Hardin reports with their grant, they were able to provide 33 programs over an 8 week period with a total summer attendance of 646 children. Activities included programs about dinosaurs, construction vehicles, ancient Egypt, animals that live under the ground, magic, ogres, worms and pirates. Each week the library provided three programs divided into age groups.

Domestic and Sexual Violence Services of Red Lodge was busy in October, training teachers to use their program of "Power UP, Speak Out". With their grant, they were able to order the necessary program toolkits and give them to the teachers at no cost.


Billings Community Foundation is honored to support these programs and others like them. We applaud their fine work.

#### **BCF Client Endowment Funds**

You can make a substantial gift to a charitable organization in the Billings region for just pennies on the dollar. We can show you how.

A federal charitable deduction for your gift is available for those who itemize on their taxes. A Montana credit is available for 40% of the present value of any planned gift to a permanent endowment up to a maximum of \$10,000 per tax payer (individual or business). A Montana credit of 20% is available for a cash gift given by a business entity to a permanent endowment.

Finally, with a gift of appreciated property, there is no recognition of the capital gain for federal or Montana income tax purposes.
